

**ONLINE ACCESS AGREEMENT & TERMS**  
Office of the Chapter 13 Standing Trustee – Tacoma

1. The Office of the Chapter 13 Standing Trustee Service through the 13Network consists of inquiring and retrieval of information provided for interested parties (collectively known as “Users”). These terms and any further Operating Rules published online constitute the entire and only agreement between the Trustee, and the Users and supersedes all other communications and agreements with regard to the subject matter hereof.
2. The trustee may modify this agreement, the operating rules and may discontinue or revise any or all other aspects of the service at its sole discretion and without prior notice.
